## **TOURNAMENT REFUND AND CANCELLATION POLICY**

All monies paid toward Legends Ballpark tournaments are non-refundable, with the exception of refunds pursuant to tournaments cancelled by Legends Ballpark.

If a tournament is cancelled by Legends Ballpark, due to low team participation or any other reason other than inclement weather or state/federal emergency, Legends Ballpark will refund all monies paid to team contact, including any deposits paid, AND issue a credit towards a free tournament of equal value. Credits must be used 12 months from the date of the originally scheduled tournament.

**In cases of state or federal emergencies, Legends Ballpark will provide a credit to your team or organization for entrance into a future tournament. Credits will expire as noted above.**

## **PAY SCHEDULE & BALANCE DUE**

- All tournament registrations require an initial payment; registration requires either a deposit or full payment depending on the tournament. Spaces in Legends Ballpark tournaments are not secured or reserved without submitting an initial payment.
- Initial deposits or full payments are collected at the time of registration.
- Balances are due 30 days prior to the tournament date and will automatically be processed using the payment method on file for the individual that registered for the tournament.
- Legends Ballpark reserves the right to remove teams or participants from programs, without refund, credit or other future consideration, if scheduled payments are not made.

## **CREDITS**

- Cancellations by teams may result in full or partial credits for customers, depending on how much advance notice is provided in writing to Legends Ballpark. For details, please see chart below.
- Credits must be used 12 months from the date of the originally scheduled tournament.

**CREDIT POLICY: 3-GAME OR 4-GAME TOURNAMENTS**

Full credits (all monies paid) or partial credits (all monies paid less the initial deposit) will be available based on the number of days between the date of cancellation and the first day of the tournament:

	<b>More than 90 days notice</b>	<b>30-90 days notice</b>	<b>Fewer than 30 days notice</b>
<b>Deposit</b>	YES	NO	NO
<b>Balance</b>	YES	YES	NO

Note: cancellation notice must be provided in writing by contacting [tournaments@legendsbp.com](mailto:tournaments@legendsbp.com). If your team or organization does not show up or contacts us after the tournament has taken place, no refund or credit of any kind will be issued.

**INCLEMENT WEATHER POLICY**

There will be no refunds issued due to weather cancellations. Teams will be issued a credit towards another Legends Ballpark tournament.

Future considerations for tournaments impacted by inclement weather will be awarded as follows:

- 0 Games Played: 100% Credit
- 1 Game Played: 75% Credit
- 2 or more games played is considered an "Official Tournament" and no credits will be issued.

Credits will expire at the end of the calendar year following the year in which the originally purchased tournament occurred.
